We give you information and advice on your rights according to the law and your collective agreement, about the latest changes in the law and about current political issues.

We elect the members of the bargaining commission and the board members of our democratic organization.

We negotiate about salaries, working hours, holidays, holiday and Christmas bonuses and other working conditions with the employers. We deal with about 1,000 collective agreements each year.

We fight for our rights and demands with information, demonstrations and if necessary by going on strike.



Direct debit mandate
